In consideration of being permitted to compete, officiate, observe, work for, or participate in any way in the event(s) or being permitted to enter for any purpose any restricted area (defined as any area requiring special authorization, credentials, or permission to enter or any area to which admission by the general public is restricted or prohibited), each of the undersigned, for him/herself, legal representatives, heirs, and next of kin:

- Acknowledges, agrees, and represents that he/she has or will immediately upon entering any of such restricted areas, and will continuously thereafter inspect the restricted areas, which he/she enters, and he/she further agrees and warrants that, if at any time he/she is in or about restricted areas, and he/she feels anything to be unsafe, he/she will immediately advise the officials of such and if necessary will leave the restricted areas and/or refuse to participate further in the event(s).
- Hereby releases, waives, discharges, and covenants not to sue the ISOC, or the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, and their respective directors, officers, licensees, employees, successors and assigns from and against all claims, liability, loss or expense, including reasonable attorney's fees, which may result from the use of the above.
