## CONDITIONS OF CONTRACT

Kawartha Powersports Show Management agrees to provide the Exhibitor with designated display space. Space contracted by the Exhibitor may not be sublet without the prior written permission of Management. The Exhibitor agrees to abide by all regulations and rules adopted by Management in the best interest of the Show and agrees that Management shall have the final decision in adopting any rule or regulation deemed necessary prior to, during and after the Show.

Exhibitor will be liable and will indemnify and hold harmless Management, Canadian Powersports Racing Assoc., Avann Racing Inc. from any loss or damages whatsoever suffered as a result of any loss or damage whatsoever occurring to or suffered by any person or company including, without limiting the generality of the foregoing, Exhibitor, other exhibitors, Management, the owner of the building and their respective agents, servants and employees and members of the public attending the Show, either on the said space or elsewhere if said loss or damage arose from or was in any way connected with Exhibitor's occupancy of said space.

This contract is binding upon exhibitor's signature in accordance with registration requirements. No refund, credit or reimbursement will be allowed upon cancellation of this contract and full payment is required.

Management reserves the right to alter or change the space assigned to the Exhibitor.

Management reserves the right, at any time, to alter or remove exhibits or any part thereof including printed materials, product signs, lights or sound and to expel Exhibitors and/or their personnel if, in Management's opinion, their conduct or presentation is objectionable to Management or other Show participants.

Exhibitor agrees to confine his presentation within the contracted space only during Show hours.

All goods shipped to the Show must be clearly marked with the name of the Exhibitor and the number of his space. Goods must not be shipped to Show for shipping charges to be paid on arrival as these will not be accepted by the Management.

Management assumes no responsibility for loss or damage to goods before, during the period of the Show, or after its closing.

The Exhibitor is responsible for the placement and cost of insurance related to his participation in the Show.

The Exhibitor to remove his exhibit equipment and appurtenances from the Show grounds by the final move-out limit, or in the event of the failure to do so, the Exhibitor agrees to pay for such additional costs as may be incurred.

Management reserves the right, at its sole discretion, to change the date or dates upon which the Show is to be held and shall not be liable in damages or otherwise by reason of any such change. In addition, Management shall not be liable in damages or otherwise for failure to carry out the terms of this Agreement in whole or part where caused directly or indirectly by or consequence of fire, storm, flood, war, rebellion, insurrection, riot civil commotion, strike or by any cause whatsoever beyond the control of Management whether similar to or dissimilar from the causes enumerated herein.

Management reserves the right to cancel this contract and to withhold possession of exhibit space if Exhibitor fails to perform any material condition of this contract or refuses to abide by the Show rules and regulations, in which case the Exhibitor shall forfeit as liquidation damages all space rental payments made by him and further occupancy of such space.

The Exhibitor agrees this contract is an agreement for display space strictly for the person listed. No subletting is permitted.
